*EXCLUSIONS FOR "KEEP FULL PROGRAM"

Below is a partial list of parts and services excluded from our program. Exclusions are not limited to this list.

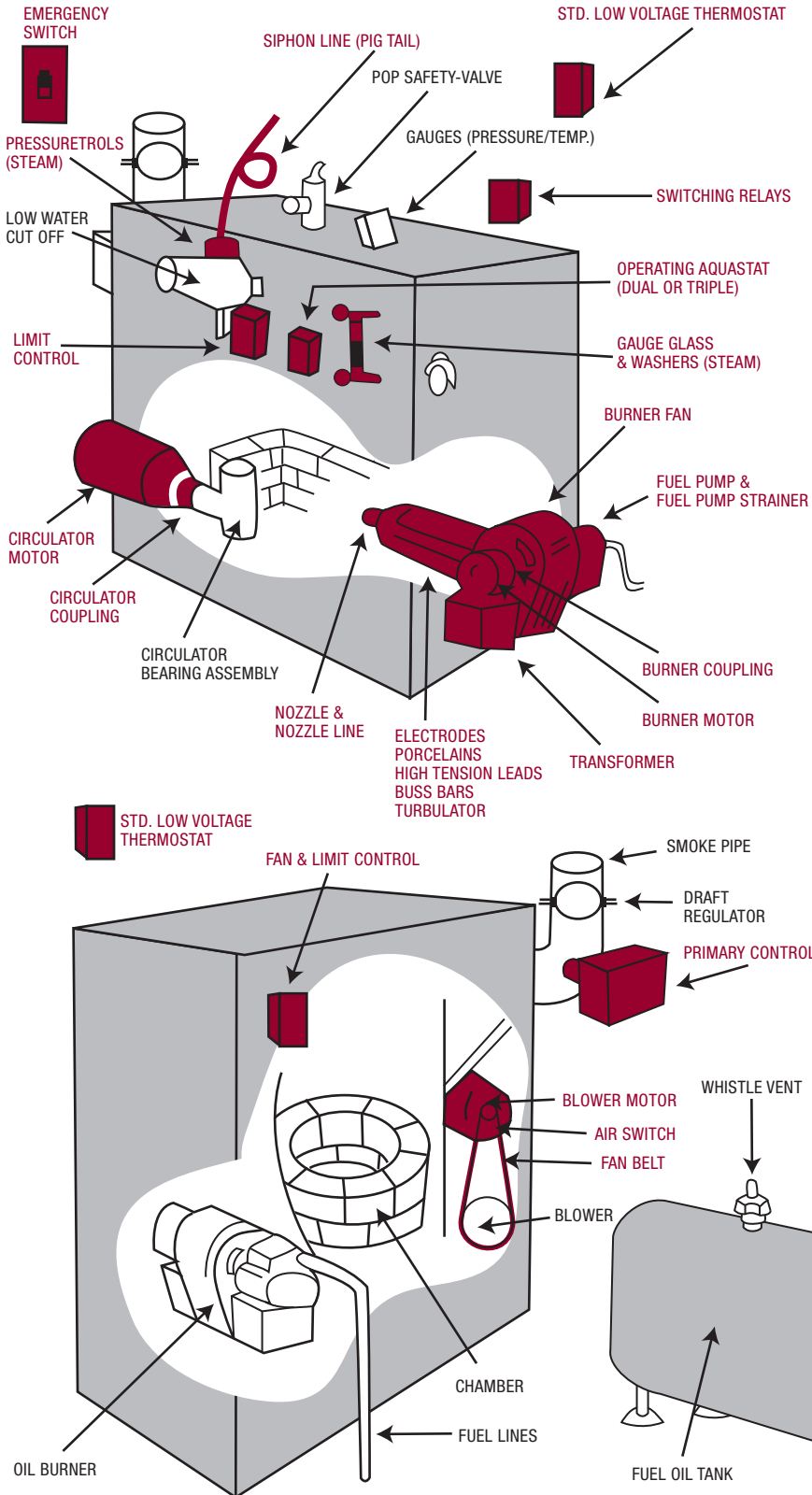
- Heating system: The furnace/boiler and its related parts such as pressure gauges, smoke pipe, jacket or asbestos, domestic water heating equipment (unless covered), piping from the furnace/boiler to heat outlets and radiators, registers and ductwork.
- FROZEN FUEL LINES
- Fuel tanks
- Fireproofing
- Electronic air cleaners, humidifiers, air filters and other ancillary air conducting equipment.
- Wiring other than the oil burner circuit
- Low water cut-off
- Pressure relief valve
- Tank fittings, fuel lines (other than nozzle lines)
- Water storage tanks
- Fuel tank gauges
- Expansion tanks
- Calls for janitorial service, problems of tenant-landlord relations, or calls resulting from lack of supervision or neglect are not included in the program

Where repeated burner failure results from fuel tank deterioration, or an accumulation of water, sediment an/or algae, program coverage for calls related to this condition will be suspended until corrective work is performed at the owner's expense.

NOTE: Systems with more than one circulator will be afforded coverage on the main circulator only.

GENERAL TERMS AND CONDITIONS

1. Customer agrees to purchase all fuel oil requirements from us during the term of this program or contract is void.
2. Our programs do not cover services required on boilers or furnaces, heating or water piping, duct work, radiators, registers, expansion tanks, water storage tanks, wall pumps, zone valves, or water feeders, low water cut-off, domestic hot water coils, acid flushing, bearing assemblies, pressure reducing relief valves, humidifiers, combustion chambers, fuel storage tanks, or any other control or part of the heating system not specifically described in this plan, or on units firing a three gallon or more nozzle.
3. We reserve the right to inspect the equipment covered before accepting this program.
4. This program is void if the buyer permits any person other than our employees to render service to the equipment except as instructed by us.
5. Prices quoted refer to domestic type heating equipment only. Prices on other types available on request.
6. This program does not cover parts damaged by water, fire, act of God, accident, tampering, or abuse.
7. Our obligation to furnish any parts is subject to their availability through normal sources of supply; obsolete equipment will involve additional charges.
8. This program includes only repair and replacement parts specifically listed which are defective due to normal wear.
9. This program does not include equipment failures resulting from customer's refusal of automatic delivery and being a "WILL CALL" account.
10. This program does not cover liability for injury or damage resulting from defect's in, or the operation or non-operation of customer's burner or its appurtenances or any other equipment, nor does it cover liability for loss or damage resulting from delay or failure to perform hereunder due wholly or partially to labor disturbances, fires, lack of material, governmental regulations, or any causes beyond our control such as runouts due to nonpayment of bills.
11. This program contains the full understanding of the parties here to and there are no promises, terms, conditions or obligations other than printed herein.
12. All Burner Agreements become void in event of change of ownership unless new owner continues purchase of fuel oil (automatic delivery) from Sprague's Oil Service, Inc.
13. If customer's credit becomes impaired during the life of the Burner Service Agreement, all service will be discontinued until credit status has been reinstated.
